## **FRESH-COOLED SEMEN EXPORT TO CANADA**

### **Step- by- Step Procedures:**

Canadian importers must apply for an import permit from CFIA directly, or through your veterinarian. For information on the permit, call CFIA at 604-557-4500, or visit their website at: <http://www.inspection.gc.ca/animals/terrestrial-animals/diseases/reportable/cem/germplasm/eng/1356161461430/1356161577650>. Please also read the section on Valuation of Semen Imported to Canada, at [www.cbsa-asfc.gc.ca/publications/cn-ad/cn11-020-eng.pdf](http://www.cbsa-asfc.gc.ca/publications/cn-ad/cn11-020-eng.pdf). The value of the breeding fee must be included in the paperwork. You must have the verified import permit before we can ship semen to you. You can apply for a single entry permit, in which case we will need the original in our possession before we can ship you semen. You can also apply for a multiple entry permit, which is good for multiple shipments throughout the entire breeding season. This option is highly recommended. We will need only a copy of this (not the original) before we can ship you semen. Please talk with your veterinarian before applying for an import permit. They may already have a multiple shipper import permit and can add our farm to the list.

Please use our physical address when filling out your import permit: Wild Turkey Farm, 14175 SW Wilsonville Rd, Wilsonville, OR 97070. **DO NOT USE OUR MAILING ADDRESS, AS THE IMPORT PERMIT WILL THEN HAVE TO BE RE-ISSUED WITH OUR PHYSICAL ADDRESS BEFORE WE CAN SHIP YOU SEMEN.** This may delay your shipment if you have scheduled for your mare to be bred on a certain date.

When we have a copy of your import permit (or the original permit if a single entry permit was applied for), we can then collect the semen and fill out our USDA Health Certificate needed to accompany the shipment. The original Health Certificate will be sent overnight to our USDA office in Olympia, WA for endorsement. It will then be electronically sent CFIA for border clearance. A copy of the un-endorsed Health Certificate will accompany the semen shipment. Please work closely with your veterinarian as to when the semen should be shipped in order to optimize the chances of your mare getting in foal on the first shipment.

**PLEASE NOTE: THERE WILL BE NO FRESH COOLED SEMEN SHIPMENTS ON FRIDAYS, SATURDAYS AND SUNDAYS.** Our USDA offices are closed on Saturdays and Sundays, so are unable to endorse the export health certificate for weekend border clearance.

All monies owed to Wild Turkey Farm, including Breeding Fee, collection/shipping fee, USDA endorsement fee and Fed-Ex fee for Health Certificate must be paid in full before semen will be shipped.
